Quarterly asylum statistics

August 2020

This briefing covers the latest quarterly asylum statistics. For annual and longer term trends see the Refugee Council briefing on asylum trends.

The most recent period for which statistics have been published is the 2nd quarter of 2020, April to June. Many of the figures show the impact of coronavirus and the lockdown restrictions and differ significantly from previous quarters as a result.

APPLICATIONS:

 The number of applications for asylum in the UK decreased sharply in Q2 2020 compared with previous quarters.

Applications by nationality:

• Compared with the corresponding quarter in 2019 there was a decrease in the number of applicants from eight of the top ten countries of origin. The only increases were Syrian and Stateless applicants. 'Stateless' has never previously featured in the top ten.

Applications by location

• The proportion of applications made at ports and in-country has changed only marginally in the past few quarters before Q2 2020 but increased hugely to 97% in Q2 2020.

DECISIONS:

- In Q2 2020 2,734 initial asylum decisions were made, excluding dependants; a large decrease compared with previous quarters.
- 35% of initial decisions in Q2 2020 were to grant asylum, much lower than previous quarters. 3.4% of initial decisions in Q2 2020 were to grant Humanitarian Protection or Discretionary Leave, similar to Q2 2019 and 59% were refusals, a large increase from earlier quarters.

 Countries with an above average percentage of applicants granted protection in Q2 2020 included Iran, Eritrea, Sudan and Syria. Several countries had very high refusal rates.

APPEALS:

- 462 appeals were determined in Q2 2020, a large decrease from the previous four quarters.
- The proportion of appeals allowed was 37% in Q2 2020, while 48% were dismissed. The remainder were withdrawn and the percentage withdrawn was higher than usual.

ASYLUM SUPPORT:

- The total number of asylum seekers (including dependants) in receipt of Section 95 asylum support at the end of Q2 2020 was 45,769, an increase from the previous four quarters.
- 3,480 of these asylum seekers were receiving subsistence only support at the end of Q2 2020.
- 42,289 of these asylum seekers were supported in dispersal accommodation at the end of Q2 2020
- The region of the UK with the largest number of people in dispersal accommodation at the end of Q2 2020 was the North West (10,083).
- 5,444 asylum seekers were in initial accommodation under Section 98 support at the end of Q2 2020, a large increase from previous quarters.

ENFORCEMENT & COMPLIANCE:

Removals (Asylum Applicants)

- In the year ending June 2020 2,216 asylum seekers were removed or departed voluntarily from the UK, a 38 decrease from the year ending June 2019 (3,555).
- 999 asylum seekers left via enforced removals from the UK in the year ending June 2020, a 46% decrease from the year ending June 2019 (1,835).
- 1,217 asylum seekers left under Voluntary Return schemes in the year ending June 2020, a 29% decrease from the year ending June 2019 (1,720).

Note: The most recent figures are often revised in subsequent statistical releases, usually upwards, so percentage decreases can change significantly when this happens.

Detention

Persons entering and leaving detention

In the year ending June 2020 a total of 19,128 people were recorded as entering detention of whom 11,427 were asylum cases. In the same period 20,097 people left detention of whom 12,379 were asylum cases. Some people may have been in detention more than once.

Persons Detained at the end of Q2 2020

- At the end of Q2 2020 a total of 698 persons were detained, at this point no children were in detention.
- 292 persons who had sought asylum at some stage were being detained solely under Immigration Act powers (42% of all immigration detainees)
- 41 children were recorded as entering detention in the year ending June 2020.

CHILDREN:

Applications by Unaccompanied Children Seeking Asylum

The number of applications from unaccompanied children, excluding dependants, was 118 in Q2 2020, a large decrease from previous quarters.

Iraq was the top country of origin for unaccompanied children (20% of all applications in Q2 2020). Afghanistan accounted for 17%, Iran for 16%, Sudan for 13%, Eritrea for 10% and Syria for 8%. Together these six countries accounted for over 80% of all applications in O2 2020.

- In Q2 2020 only 2.5% of applicants were female, a much lower percentage than usual.
- In Q2 2020 only 3 asylum applications by unaccompanied children were made by girls.
- There are a small number of applications recorded as sex unknown.

Age Disputed Cases

• The number of age disputed cases raised in Q2 2020 was 31, a large decrease compared with the previous four quarters. Afghanistan (9), Iran (6) and Iraq (5), were the countries of origin with the largest number of age disputed cases in Q2 2020.

N.B. The Home Office statistics on age disputed cases do not include the category of those applicants who claim to be children but who are treated as adult, according to Home Office policy. This used to state that in the opinion of an Immigration Officer "their physical appearance and/or general demeanour **very strongly** indicates that they are **significantly** over 18 years and no other credible evidence exists to the contrary" but the wording has changed since June 2019 to "very strongly suggests that they are 25 years or over".

Decisions

• If an unaccompanied child's claim for international protection is refused, they may be granted UASC leave. Since 2013 this leave is granted in cases where the only reason for giving leave is that the applicant is a child who cannot be returned. It is not granted for anyone over the age of 17 and a half. Very few decisions were made in Q2 2020.

ASYLUM APPLICATIONS (DEPENDANTS):

- In Q2 2020 there were 939 dependants included in asylum applications.
- 649 of the dependants were under 18 years old and 494 were female.

FAMILY REUNION:

Adults who have been granted refugee status or humanitarian protection are entitled to apply for family reunion. Immediate family members, defined as spouses or partners and children under the age of 18 are eligible to apply for entry to the UK.

The very small number of cases dealt with in Q2 2020 will mean there is a very significant backlog of applications.

WOMEN AND GIRLS:

• In Q2 2020 there were 1,087 applications where the main applicant was a woman or girl. This represents 22% of all applications, a similar figure to previous quarters, bearing in mind the very small number of applications from unaccompanied girls in this quarter.

The proportion of female applicants varies considerably from country to country. For a very small number of countries there are more female than male applicants whereas in many countries the percentage of female applicants is low. Among the countries with the largest number of female applicants in Q2 2020 China, Nigeria, Philippines and Kenya have high percentages.
