Quarterly asylum statistics

March 2021

This briefing covers the latest quarterly asylum statistics. For annual and longer term trends see the Refugee Council briefing on asylum trends.

The most recent period for which statistics have been published is the final quarter of 2020. Many of the figures in the last 3 quarters show the impact of coronavirus and the lockdown restrictions and differ significantly from previous quarters as a result.

APPLICATIONS:

• The number of applications for asylum in the UK decreased sharply in Q2 2020 compared with previous quarters but rose again in Q3.

Applications by nationality:

• Compared with the corresponding quarter in 2019 there was an increase in the number of applicants from three of the top ten countries of origin. There were very large percentage increases for Sudanese and Syrian applicants. El Salvador has never featured in the top ten before Q4 2020.

Applications by location

 The proportion of applications made at ports and in-country changed only marginally before Q2 2020 but increased hugely to 97% in-country in Q2 2020 and remained high, at 89%, in Q3 and then fell to 79% in Q4.

DECISIONS:

- In Q4 2020 3.728 initial asylum decisions were made, excluding dependants; an increase on the previous two quarter but still lower than earlier quarters.
- 40% of initial decisions in Q4 2020 were to grant asylum, an increase on the previous two quarters. 3.7% of initial decisions in Q4 2020 were to grant Humanitarian Protection or Discretionary Leave, and 55% were refusals, a large decrease from Q3.

APPEALS:

- 874 appeals were determined in Q4 2020, an increase from Q2 and Q3 but still lower than the previous quarters.
- The proportion of appeals allowed was 38% in Q4 2020, while 47% were dismissed. The remainder were withdrawn and the percentage withdrawn was higher than usual.

ASYLUM SUPPORT:

- The total number of asylum seekers (including dependants) in receipt of Section 95 asylum support at the end of Q4 2020 was 45,626, similar to the previous two quarters.
- 4,324 of these asylum seekers were receiving subsistence only support at the end of Q4 2020.
- 41.302 of these asylum seekers were supported in dispersal accommodation at the end of Q4 2020
- The region of the UK with the largest number of people in dispersal accommodation at the end of Q4 2020 was North West England (9,592).
- 12,235 asylum seekers were in initial accommodation under Section 98 support at the end of Q4 2020, a very large increase from quarters earlier than Q3.

ENFORCEMENT & COMPLIANCE:

Removals (Asylum Applicants)

- In the year ending September 2020 1,831 asylum seekers were removed or departed voluntarily from the UK, a 43% decrease from the year ending September 2019 (3,221).
- 687 asylum seekers left via enforced removals from the UK in the year ending September 2020, a 53% decrease from the year ending September 2019 (1,464).
- 1,144 asylum seekers left under Voluntary Return schemes in the year ending September 2020, a 35% decrease from the year ending September 2019 (1,757).

Note: The most recent figures are often revised in subsequent statistical releases, usually upwards, so percentage decreases can change significantly when this happens. The figures up to December 2020 have not yet been published.

Detention

Persons entering and leaving detention

In the year ending December 2020 a total of 14,773 people were recorded as entering detention of whom 9,620 were asylum cases. In the same period 15,449 people left detention of whom 10,320 were asylum cases. Some people may have been in detention more than once.

Persons Detained at the end of Q4 2020

- At the end of Q4 2020 a total of 910 persons were detained, at this point no children were in detention.
- 438 persons who had sought asylum at some stage were being detained solely under Immigration Act powers (48% of all immigration detainees)
- 23 children were recorded as entering detention in the year ending December 2020.

CHILDREN:

Applications by Unaccompanied Children Seeking Asylum

• The number of applications from unaccompanied children, excluding dependants, was 562 in Q4 2020, lower than in three of the previous four quarters.

• Afghanistan was the top country of origin for unaccompanied children (20% of all applications in Q4 2020). Eritrea accounted for 16%, Sudan for 15%, Iran for 13%, Syria for 8% and Vietnam for 6%. Together these six countries accounted for nearly 80% of all applications in Q4 2020.

- In Q4 2020 only 8% of applicants were female, a slightly lower percentage than usual.
- In Q4 2020 46 asylum applications by unaccompanied children were made by girls.
- There are a small number of applications recorded as sex unknown.

Age Disputed Cases

• The number of age disputed cases raised in Q4 2020 was 251, a decrease compared with Q3. Afghanistan (68), Sudan (39), Iran (35), and Eritrea (31) were the countries of origin with the largest number of age disputed cases in Q4 2020.

N.B. The Home Office statistics on age disputed cases do not include the category of those applicants who claim to be children but who are treated as adult, according to Home Office policy. This used to state that in the opinion of an Immigration Officer "their physical appearance and/or general demeanour **very strongly** indicates that they are **significantly** over 18 years and no other credible evidence exists to the contrary" but the wording has changed since June 2019 to "very strongly suggests that they are 25 years or over".

Decisions

• If an unaccompanied child's claim for international protection is refused, they may be granted UASC leave. Since 2013 this leave is granted in cases where the only reason for giving leave is that the applicant is a child who cannot be returned. It is not granted for anyone over the age of 17 and a half. A smaller number of decisions than usual were made from Q2 2020.

- In Q4 2020 there were 1,813 dependants included in asylum applications.
- 1,306 of the dependants were under 18 years old and 1,051 were female.

FAMILY REUNION:

Adults who have been granted refugee status or humanitarian protection are entitled to apply for family reunion. Immediate family members, defined as spouses or partners and children under the age of 18 are eligible to apply for entry to the UK.

The number of cases dealt with has increased from the very small number of cases dealt with in Q2 2020 but that may be due to a significant backlog of applications.

WOMEN AND GIRLS:

• In Q4 2020, there were 1,680 applications where the main applicant was a woman or girl. This represents 22% of all applications, similar to previous quarters.

• The proportion of female applicants varies considerably from country to country. For a very small number of countries there are more female than male applicants whereas in many countries the percentage of female applicants is low. Among the countries with the largest number of female applicants in Q4 2020 China and Nigeria have high percentages.
